There will be a total of one (1) entry period opening June 18 2024 at 12:00am PT and closing September 15, 2024 at 11:59pm PT, when all entries must be received ("Promotion Period"). Please see section 5. PRIZE DESCRIPTION AND REDEMPTION CONDITIONS for a list of entry periods and prizes.

2. ELIGIBILITY. Sweepstakes is open only to legal residents of the 50 United States and District of Columbia who are at least twenty-one (21) years of age at time of Sweepstakes Entry.

- III.Find Serial wines at a store near you. After you register for the sweepstakes you may click the "Find Serial wines near you" button. By completing this task, you will earn ten (10) bonus entries. Limit: Each entrant can earn ten (10) bonus entries for completing this step during the Sweepstakes Period.
 - 4. WINNER SELECTION AND NOTIFICATION. Winner selection will be conducted by random drawing from all eligible entries. Drawings will take place on 9/16/24, 12pm PT (the "Drawing Date"). Any potential winner will be notified by email. If a potential winner: (i) cannot be contacted; (ii) does not respond within 24 hours from the date the Sponsor first tries to notify him/her; (iii) fails to return the Affidavit and Release as specified in Rule 9; (iv) refuses the prize; and/or (v) the prize or prize notification is returned as undeliverable, such potential winner

forfeits all rights to win the Sweepstakes or receive the prize, and an alternate potential winner may be selected.
